### Participants from EU / EFTA Countries

Participants who hold a valid European Firearms Passport (EFP) may import their weapons into Switzerland without additional permits.

However, all weapons – including air guns – must be listed in the EFP.

### Participants from Non-EU / EFTA Countries (e.g. UK, USA etc.)

Participants from non-EU or non-EFTA countries, or those without a valid European Firearms Passport, must obtain a Swiss import permit in accordance with Article 40a of the Swiss Weapons Ordinance (WV).

#### Deadlines and conditions:

The completed application form (annex 5) and copies of the athletes' passports must be submitted no later than July 3rd, 2026.

The processing time by fedpol is usually at least 10 working days.

Entry into Switzerland without a valid permit may be refused and could result in legal consequences.
